1 Meeting called to order at 18:03.

### 2 Adoption of Agenda

Motion 1: Micah Olesh/Caitlyn Carey

To approve the agenda as amended, added a new item: Swimming Lessons.

#### 4 Treasurer's Report

• We received an outstanding invoice from Paul Davis for an online presentation. Jesse to speak with Taelor to clear up whether Council ever agreed to pay this. Council confirms that we should pay the invoice, regardless and will resolve ultimate responsibility for payment with Education subsequently.

### Action: Council to pay invoice from Paul and will request full or partial contribution from YG, Ed.

- The Council is running out of cheques and will order another batch.
- The Victoria Gold closure will not affect the Every Student Every Day fund. The Cheque will be cashed.

### 5 Principal's Report

- Enrolment hasn't changed since the last report in September. There isn't much room left in K or Gr. 7.
- EAs took Non-Violent Crisis Intervention Training.
- School took part in Truth and Reconciliation activities.
- Official school photos were taken.
- The school was informed about protocol around Ed Psych listing including plans and other pre-Ed Psych interventions.
- The new TKC Education director toured the school.
- Reported accidents are all minor incidents except one that involved a child with a head injury from tripping while walking backward.
- School Growth Plan committee meeting will take place on October 16<sup>th</sup> at 15:30.
- Incomplete actions items update:

- o The perimeter trail still needs some mulch to fill in the holes and uneven spots. Trail maintenance falls in the purview of Dept. of Education rather than Property Management. We'll expect a spring fix up.
- o The dirt pile of the outdoor structure has been removed.
- o The fence between the fire pit and the outdoor structure will be removed.
- o In Dec 2024, the water in the schools will be retested. The old fountains have been closed off and the new fountains have been retested and shown to have lead levels within acceptable health thresholds.
- <u>o</u> The school bought radon tests and can give Council the results in three months when the testing is complete. <u>Action: Follow up in January 2025 for Radon test results.</u>
- o The FN language teacher position closed with no applicants. Also open is on EA position and a library clerk position. The FN language teacher staffing position has been reallocated to a cultural teacher until a successful applicant for the language instructor is found.

### **6** Committee Reports

### 1.Transportation Committee:

• No meeting has been held yet. Communication from Standard has fallen off somewhat from last year. Bus no. 19 was cancelled with no word given to the school.

### 2. Health and Safety Committee:

- A meeting was held. Caitlyn attended. Radon, air quality, and the unreliability of cell phone coverage within the building.
- Scott is to make the next two meetings instead of Caitlyn Oct 30<sup>th</sup> and Nov 27<sup>th</sup> at 15:30 at the school.
- No mould investigation has taken place at the school, but the possibility has been brought up by one employee.
- The land lines have been noted to be full of static which is worrying in light of the unreliability of the local cell network.

### 3. School Growth Plan:

No meeting yet. First meeting to be on October 16<sup>th</sup> at 15:30 at the school.

### 7 Old Business & Correspondence

### 1. ESED Project Updates:

- Lets Talk Science is being overseen by lan Dimos. <u>Action: Jesse to connect with lan and Jeff for current ESED funding expenditures.</u>
- Note that experience at Yukon U has shown that 3D printers are very fragile.
- Skills Canada has a robotic component.
- There is to be a "decolonizing" art wall in the library.

### 2.Fundraising Planning & Updates

- Purdy's Chocolate:
  - Council discussed selling chocolate as a fundraiser. Rosemary Popadynec typically raises funds with the grade threes with this activity. <u>Action: Jeff to ask Rosemary if Council can</u> raise funds selling Purdy's Chocolate.
  - o A catalogue may cost money, but the sales can be done online.
  - o Money the Council raises through chocolate sales may be earmarked for field trips.
- Pancake breakfast
  - o Dec 16<sup>th</sup> is the PCSS pancake breakfast and typically the JHES attend. JHES could have their pancake breakfast on the 14<sup>th</sup> of February it's a Friday and Valentine's day.
  - o Richard volunteered to pay for the coffee for the pancake breakfast.

## o <u>Action: Jesse to confirm with Brenda Stehelin that YFNED is handling the cooking of the pancakes and the supply of food.</u>

• Flower baskets – deferred until after Christmas

### 3. Review & Update Action Items from 4 September, 2024, Meeting:

- The revised invoice from Paul is to be paid.
- The newer fountains that were found to have acceptable water are open and the older fountains have not been retested or opened.
- Scott was put in touch with the Transportation Committee. No meeting has yet occurred.
- Jeff confirmed dates and times for the Health & Safety and School Growth Committee meetings.

### 5. School Allergy Policies

- Caitlyn reviewed the feedback received. 80 responses were received. 90% of respondents were in favour of changing the policy.
- Council should get in contact with the École Émilie-Tremblay School Council for feedback on how their policy change was rolled out and ask if anything should be noted. Council should also reach out to WB School Council who also wish to change the allergy policy and work with them and with AYSCBC. Action: Jesse to raise the issue at AYSCBC.
- It's noted that many other allergies exist and aren't catered to in the same way in the schools as nut allergies are.
- All staff members have been trained in the use of EpiPens.

### 6. Swimming Lessons

- \$1,214 for standard buses and swim lesson fees together. Gr. 2 and 4 to go in April and May
- \$5,100 for grades 2,3, 4 for 108 students. If a couple of parents can drive children, then we won't need the standard bus.
- School Council fundraising can be flagged specifically for swimming lessons.
- Could the school use the Cobalt buses? They are willing, but what are the Dept. of Ed. rules?
- The school buses have a storage cage in them. If the storage cage could be removed, more seats
  could be added so additional buses aren't required to move children to the pool. <u>Action: Jeff to ask</u>
  <u>Fleet if replacing the storage cages with seats is a possibility.</u>

### 7. Council Member Advertisement

- Three available positions were advertised on the web site. It could also be advertised in the school newsletter.
- One application was received from Cristi Frittaion.

### Motion 2: Micah Olesh/Scott Holiday

To accept the application of Cristi Frittaion to join School Council.

Passed by: Consensus Unanimous

### • Action: School Council must write a letter to Richard confirming its desire to accept Cristi's application.

• Richard to get nomination papers signed for Cristi. It will likely take four weeks.
